Total Collection income: \$640.1K YTD.

# **Towers of Faith Update:**

- 39 households are participating
- Designated amounts of which we are aware amount to near \$1M, remaining amounts undisclosed.
- \$172K given since 2006
- Pending donations \$60K + 25% of an estate, amount unknown

## **Building and Maintenance:**

- Discussed options on sidewalk, maintenance/repair. Plan is to use outside contractor.
- Tree trimming needs attention. Considering longer term landscape issues.
- Flooring maintenance and cleaning costs can be reduced by 50%, options being considered. A \$5K expense being considered for 2012.

### **Personnel Report:**

- New youth advocate does not require health benefits. Which is a cost saving for the parish.
