To relieve high costs, the process of getting proposals for solar energy is in underway.

To prevent and discourage damage to our campus the security options are a) \$50,000 bid to monitor entire site b) \$2,000 camera with sharp visual quality may cover 50% of the of property c) security guard \$300 is currently in use.

Plan from council to keep security guard for now and request price for 2 cameras.

New Business:

Joe Garcia is having to do less cleaning, due to hiring out cleaning company, and he is happier with constant projects to be done with the buildings.

A new sound engineer needs to be hired, Jim Treat has left our community. We also need an enclosure for the sound equipment.
